LICENSE AGREEMENT FOR SessionTO SOFTWARE

IMPORTANT-READ CAREFULLY:

This Corhoma License Agreement is a legal agreement between you (either an individual or a single entity) and Corhoma SRL for the Corhoma software product(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT").

By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this License Agreement. If you do not agree to the terms of this License Agreement, do not install or use the SOFTWARE PRODUCT.

The SOFTWARE PRODUCT is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The SOFTWARE PRODUCT is licensed, not sold.

1. GRANT OF LICENSE. The SOFTWARE PRODUCT is licensed as follows: Installation and Use. Corhoma SRL grants you the right to install and use copies of the SOFTWARE PRODUCT on your computers running validly licensed copies of the operating system for which the SOFTWARE PRODUCT was designed. Backup Copies. You may also make copies of the SOFTWARE PRODUCT as may be necessary for backup and archival purposes.

As a software developer, you are authorized to copy and distribute only the ActiveX component with your developments as many times as you need.

2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

Maintenance of Copyright Notices.

You must not remove or alter any copyright notices on all copies of the SOFTWARE PRODUCT.

Distribution.

You may only distribute copies of the the ActiveX component to third parties according to topic 1 previously described.

Prohibition on Reverse Engineering, Decompilation, and Disassembly.

You may not reverse engineer, decompile, or disassemble the SOFTWARE PRODUCT.

Rental.

You may not rent, lease, or lend the SOFTWARE PRODUCT.

Transfer.

You may permanently transfer all of your rights under this License Agreement, provided the recipient agrees to the terms of this License Agreement.

Support Services.

Corhoma may provide you with support services related to the SOFTWARE PRODUCT ("Support Services"). Use of Support Services is governed by the Corhoma policies and programs described in the user manual, in "on line" documentation and/or other Corhoma-provided materials. Any supplemental

software code provided to you as part of the Support Services shall be considered part of the SOFTWARE PRODUCT and subject to the terms and conditions of this License Agreement. With respect to technical information you provide to Corhoma as part of the Support Services, Corhoma may use such information for its business purposes, including for product support and development. Corhoma will not utilize such technical information in a form that personally identifies you.

Compliance with Applicable Laws.

You must comply with all applicable laws regarding use of the SOFTWARE PRODUCT. All Corhoma libraries, source code, Redistributables and other files remain Corhoma's exclusive property. Regardless of any modifications that you make, you may not distribute any files (particularly Corhoma source code and other non-executable files) except those that Corhoma has expressly designated as Redistributables. Nothing in the License Agreement permits you to derive the source code of files that Corhoma has provided to you in executable form only, or to reproduce, modify, use, or distribute the source code of such files.

3. TERMINATION.

Without prejudice to any other rights, Corhoma may terminate this License Agreement if you fail to comply with the terms and conditions of this License Agreement. In such event, you must destroy all copies of the SOFTWARE PRODUCT.

4. COPYRIGHT.

All title, including but not limited to copyrights, in and to the SOFTWARE PRODUCT and any copies thereof are owned by Corhoma or its suppliers. All title and intellectual property rights in and to the content which may be accessed through use of the SOFTWARE PRODUCT is the property of the respective content owner and may be protected by applicable copyright or other intellectual property laws and treaties. This License Agreement grants you no rights to use such content. All rights not expressly granted are reserved by Corhoma.
